

**Thorntons® 'Fuel Your Love for Travel' Sweepstakes  
Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER. THE ODDS OF WINNING A PRIZE ARE SUBJECT TO THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED.**

**BY ENTERING THE SWEEPSTAKES, EACH ENTRANT (OR ENTRANT'S PARENT/LEGAL GUARDIAN, IF ENTRANT IS DEEMED A MINOR IN THE STATE OF HIS/HER RESIDENCE) AGREES TO THESE OFFICIAL RULES.**

- 1. Eligibility** - The Thorntons' 'Fuel Your Love for Travel' Sweepstakes (the "Sweepstakes") is open only to legal residents of FL, IL, IN, KY, OH and TN who are eighteen (18) years or older and have a Refreshing Rewards® card at the time of entry. Void outside of FL, IL, IN, KY, OH and TN, and where prohibited by law. No purchase necessary to enter the Sweepstakes. Participation constitutes entrant's (or entrant's parent/legal guardians, if entrant is deemed a minor in the state of his/her residence) full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. - 2. When to Enter** - The Sweepstakes begins on July 1, 2020 at 12:00:00 AM Eastern Time ("ET") and ends on September 8, 2020 at 11:59:59 PM ET (the "Sweepstakes Entry Period").

The Sweepstakes consists of one element: (4) the grand prize sweepstakes portion ("Grand Prize Pool".)

The Grand Prize Pool will be one entry pool. When an entrant clicks to load the Sweepstakes entry from their registered account on the Thorntons website (<https://www.mythorntons.com/>) or Thorntons Refreshing Rewards App (as described below), he/she will automatically receive entry into the Grand Prize Pool.

If you do not have the Thorntons Refreshing Rewards App, you may download it for free at the Apple iTunes® store or Google Play® store. Standard data rates apply.

- 3. How to Enter** - During the Sweepstakes Period, sign into your registered account at the Thorntons website or the Thorntons Refreshing Rewards App, look for the Sweepstakes entry offer, and click to load the entry. By clicking on the offer, he/she will automatically receive one (1) entry into the Grand Prize Pool.

**Or, to enter without using the Refreshing Rewards App**, hand print your first and last name, street address, city, state, zip code, email address, and your Refreshing Rewards® card number on a 3 x 5" paper/card and send in a first-class stamped envelope to: Thorntons' 'Fuel Your Love for Travel' Sweepstakes, Thorntons LLC, Marketing Department, PO Box 34230, Louisville, KY 40232, to be post-marked by date and received by date listed in the chart above. Limit of one (1) entry per outer envelope. If you do not have a Refreshing Rewards card, you may request one for free at your Participating Location. - 5. Winner Selection and Odds** - There will be a total of four (4) Grand Prize winners. On or about September 10, 2020, one (4) Grand Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Either party may enforce a final arbitration award in any court of competent jurisdiction in Kentucky, including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Kentucky. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Kentucky; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
