

**Thorntons® Monster Energy® Louder Than Life Ticket Giveaway
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER. THE ODDS OF WINNING A PRIZE ARE SUBJECT TO THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED.

Void outside of FL, IL, IN, KY, OH and TN, and where prohibited by law. No purchase necessary to enter the Sweepstakes. - 2. When to Enter** - The Sweepstakes begins on August 7, 2019 at 12:00:00 AM Eastern Time ("ET") and ends on September 4, 2019 at 11:59:59 PM ET (the "Sweepstakes Entry Period").

The Sweepstakes consists of two elements: (1) the grand prize sweepstakes portion ("Grand Prize Pool") and (5) First Prize winners.

The Grand Prize Pool will be one entry pool. When an entrant clicks to load the Sweepstakes entry from their registered account on the Thorntons website (<https://www.thorntonsinc.com/>) or Thorntons Refreshing Rewards App (as described below), he/she will automatically receive entry into the Grand Prize Pool.

- 3. How to Enter** - During the Sweepstakes Period, sign into your registered account at the Thorntons website or the Thorntons Refreshing Rewards App, look for the Sweepstakes entry offer, and click to load the entry. By clicking on the offer, he/she will automatically receive one (1) entry into the Grand Prize Pool.

Once entered, an eligible participant may purchase any Monster Energy® 16oz single can and scanning their Rewards Card or Rewards App barcode at a participating Thorntons locations to earn one (1) additional entry for every qualifying Monster Energy® 16oz single can purchased during the sweepstakes entry period.

5. **Winner Selection and Odds** - There will be a total of one (1) Grand Prize winners and five (5) First Prize Winners. On or about September 5, 2019, one (1) Grand Prize winner and five (5) First Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received.

Odds of winning depend on the number of eligible entries received.

Either party may enforce a final arbitration award in any court of competent jurisdiction in Kentucky, including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Kentucky. Any dispute

or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Kentucky; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
